
WHEREAS, Reclamation District No. 1000 maintains an Operation and Maintenance Fund held by the Sacramento County Treasurer; and

Funds held in the Reclamation District No. 1000 Operation and Maintenance Fund held by the Sacramento County Treasurer may be withdrawn or paid solely by warrant signed by any four or more of the Trustees of the District as identified in Paragraph 1 of this resolution and attested to by the Secretary of the Board of Trustees or the General Manager as identified in paragraph 2 of this resolution.
- 4. Funds on deposit in the District's revolving fund may be withdrawn or paid solely by check signed by any one of those identified in paragraph 1 of this resolution or the District Manager or District Secretary as identified in paragraph 2 of this resolution, for amounts less than \$5,000.00 and any two of the Trustees as identified in paragraph 1 or the General Manager as identified in paragraph 2 and a Trustee as identified in paragraph 1 of this resolution for amounts exceeding \$5,000.00.

RECLAMATION DISTRICT NO. 1000 OBJECTION TO TAX SALE BY SACRAMENTO COUNTY TAX COLLECTOR

RESOLUTION 2014-1-B

WHEREAS, Reclamation District No. 1000 is a reclamation district formed and operating pursuant to Division 15 of the California Water Code, pursuant to which it has authority to assess real property located within its boundaries; and

WHEREAS, Reclamation District No. 1000 has levied assessments against parcels located within its boundaries, (which are included among those listed in Exhibit B "Public Auction List - Feb 24, 2014" as prepared by the Sacramento County Department of Finance) which are delinquent.

WHEREAS, Reclamation District No. 1000 believes that those 21 parcels marked with an asterisk on exhibit B are those as to which the District's assessment is delinquent and has not been paid to the District under the Teeter plan; and

WHEREAS, the listed parcels are also encumbered by defaulted ad valorem real property taxes owing to the Sacramento County Tax Collector; and

WHEREAS, the Sacramento County Tax Collector has notified Reclamation District No. 1000 of its intent to sell the listed Parcels for defaulted taxes on February 24, 2014; and

WHEREAS, pursuant to California Revenue and Taxation Code Sections 3695 and 3712 it is necessary for Reclamation District No. 1000 to object to tax sale of the listed parcels in order to preserve Reclamation District No. 1000's assessment lien;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- 1. Reclamation District No. 1000 desires to maintain its assessment lien against the listed parcels; and ,
- 2. Reclamation District No. 1000 hereby objects to the proposed tax sale of the listed Parcels by the Sacramento County Tax Collector; and
- Reclamation District No. 1000 hereby authorizes its agents to file a certified copy of this Resolution objecting to the proposed tax sale of the listed Parcels by the Sacramento County Tax Collector with the Sacramento County Board of Supervisors and the Sacramento County Tax Collector pursuant to California Revenue and Taxation Code Section 3695.
